

SUISA's General Meeting approves emergency support fund for authors and publishers of music in Switzerland and Liechtenstein

SUISA supports its members, the authors and publishers of music in Switzerland and Liechtenstein, with an emergency support fund of CHF 1.5 million. SUISA's General Meeting approved this support plan in a voting procedure which was carried out in writing. In addition, Swiss yodeller, singer, composer and publisher Melanie Oesch was elected to the SUISA Board by the SUISA members entitled to participate in the voting procedure.

Zurich, 01 July 2020–, SUISA is going to support the composers, lyricists and publishers of music in Switzerland and Liechtenstein with an emergency support fund of CHF 1.5 million. This substitutes copyright royalties that SUISA members lose due to the cancellation of events and closure of businesses ordered by the authorities. The relief measure was approved by the SUISA Board of Directors in April in view of the current precarious situation for music professionals. The SUISA General Meeting approved the emergency support fund by a large majority on 26 June.

SUISA members have already had the option of receiving an advance on future copyright revenues. This advance scheme has been extended. In addition, SUISA's authors who found themselves in an existential, financial hardship could apply for support payments from the Pension Fund. With the newly created emergency support fund, SUISA's existing assistance to its members was supplemented by an additional measure. The emergency support fund cannot be used to finance loss of income, but it can finance losses due to lack of income from copyright.

Melanie Oesch newly elected into the SUISA Board of Directors

SUISA members entitled to vote also elected the Swiss yodeller, singer, composer and publisher Melanie Oesch to the Board for the current term of office until 2023. Melanie Oesch is, as part of Oesch's die Dritten, one of the most successful representatives of traditional folklore music. She replaces Reto Parolari, who has been a member of the Board of Directors for many years. A successful composer and conductor, Reto Parolari passed away unexpectedly last December.

In addition, music publisher Michael Hug was elected to SUISA's Distribution and Works Committee (VWK), also for the current term of office until 2023. He replaces Grégoire Liechti, who was elected to the SUISA Board of Directors last year. Michael Hug is Managing Director of the Ruh Musik AG publishing house, founded in 1910. The VWK is made up of SUISA members and deals in particular with questions concerning the distribution of SUISA's revenues.

Very good 2019 annual result for SUISA

SUISA's members also approved the 2019 annual accounts of their Cooperative. Last year SUISA achieved the best result in its history and is able to distribute CHF 135 million to composers, lyricists and publishers of music. Thanks to a favourable cost deduction of 13.07% on the statements of account to rights holders, SUISA is able to distribute about 87 of 100 Swiss Francs of its income to composers, lyricists and publishers of music.

For the first time in SUISA's history, the General Meeting was held in written form due to the Covid-19 pandemic this year. For the first time in the Cooperative's history, SUISA members were able to vote and elect by post and, in the case of some members from abroad, by e-mail.
